- 2. Proposed dues of only \$10/member.
 - a. Under-executed for many items in 2019-2020 due to COVID-19.
 - b. Many activities may still not be available in Spring or Summer 2021.
 - c. 2019-2020
 - i. Senior Player dues were \$50 for USAR.
 - ii. Senior Player dues were \$25 for Capital.
 - iii. Note that number of projected v enrolled players was not bad. We were missing later March and 7s registrations.
 - d. 2020-2021
 - i. It is still unknown what USAR dues will be. This will be made up of two components: USAR and insurance.
 - ii. The new USAR Senior Club Committee may charge a fee. The status is currently unknown.
 - iii. The Capital proposed fees will be a lower amount of \$10/member; we need to set a rate, but we have an excess that is carried from previous years and will carry us through the foreseeable future. Of course, corrections may be proposed and are likely in 2021-2022.
 - iv. We do not know if there will be a club charge imposed by USAR, but it is likely. The USAR club fee was \$160 in 2019-2020.
- 3. Proposed budget is based on a typical year.
 - a. 2020-2021 should not be typical.
 - b. We should under-execute, but we need to have the budget approved for a best case since many of our expenses are in December and later.
- 4. Other items:
 - a. Note that USAR owes us \$222.02 from this year. This is in the hands of the bankruptcy court as well as many others (with much larger claims).
 - b. The new system (Sportlomo) will send deposits directly to Capital and will not go through USAR. This may result in somewhat more complicated reconciliations due to the volume.
 - c. We are still collecting the court-ordered repayments to MARFU for the embezzlement in the mid-2000 period.
